Commentary


"In Q4, the sales reached $\[\in \]$ 10.6M, which was +46% more than in Q4 2021. Considering the annual winter holiday effect and the previous quarterly sales (Q1 $\[\in \]$ 11.6M / Q2 $\[\in \]$ 8.8M / Q3 $\[\in \]$ 11.9M), we deem this a good result. The total sales for 2022 reached $\[\in \]$ 45.9M, which means +69% growth from 2021. The gold price in euros was fairly flat in Q4, with an increase of +0.66%—during 2022, it increased by +6.0%. In Q4, our gross profit was $\[\in \]$ 339K, so roughly +50% more than in Q4 2021. The annual gross profit was $\[\in \]$ 1.4M—a +82% growth compared to 2021. Account fees contributed $\[\in \]$ 339K to the annual gross profit in 2022, whereas in 2021 they totalled at $\[\in \]$ 180K (+122%). Voima Store was still in the ramp-up stage in Q4, with $\[\in \]$ 341K sales figures. We estimate that the annual revenue of the small coin and bar market in Finland is roughly $\[\in \]$ 60M to $\[\in \]$ 80M, and we expect to grow our share of this market significantly through Voima Store. In December, we wrote off $\[\in \]$ 165K of the capitalised R&D expenses dating from 2018 and 2019—this represents roughly 40% share of the total R&D expenses on Voima's balance sheet."






