

VOIMA ACCOUNT FOR AN UNDERAGED PERSON

Voima Gold Ltd - Know Your Customer Form (“KYC Form”)

The purpose of this form is to know our customers and to obtain sufficient information about our customers for the prevention of money laundering and financing of terrorism. The identifying information and other personal data of the customer can be used for the prevention, detection and reporting of money laundering and financing of terrorism and to enable the investigation of money laundering and the crime with which the property or criminal proceeds that were laundered or that were used to fund terrorism were obtained.

KEY INFORMATION REGARDING THE UNDERAGED PERSON'S VOIMA ACCOUNT:

- “Underaged person” is the owner of the Voima Account.
 - “Managing guardian” is the guardian given the power of attorney below by the other guardian to manage the Voima Account, for buying and selling gold and for making withdrawals (in gold and in euros) from the Voima Account if needed.
 - Both guardians and the underaged person can make deposits into the Voima Account.
 - Upon turning 18 years old, the underaged person will receive the full rights to manage their Voima Account as well as the right to manage authorisations in relation to the Voima Account.

Of this KYC Form to be the guardian with full power of attorney to manage the Voima Account, for buying and selling gold and for making withdrawals (in gold and in euros) from the Voima Account, until the underaged person turns 18 years old. This power of attorney is governed by the laws of Finland without regard to conflicts of laws principles that would require the application of any other law.

* = Politically exposed person is a person who works or has for the past 12 months worked in a significant public position:

- (a) as head of state, head of government, minister or deputy minister;
- (b) as a member of parliament;
- (c) as a member of the governing body of a political party;
- (d) as a member of a supreme court, a constitutional court or any other similar judicial body whose decisions are not subject to appeal, save in exceptional circumstances;
- (e) as a member of a court of auditors or a national audit office or a corresponding supreme body responsible for auditing state finances;
- (f) as a member of the executive board of a central bank;
- (g) as an ambassador or a chargé d'affaires;
- (h) as a general officer in the military, such as a General, Admiral, Lieutenant general or Major general;
- (i) as a member of the administrative, management or supervisory body of a wholly state-owned enterprise; or
- (j) as a director, deputy director and member of the board of directors of international communities.

** = A family member of a politically exposed person ("PEP") means a PEP's:

- (a) a spouse or partner treated as such by the national law of the country concerned;
- (b) the children and their spouses or the partner referred to above; and
- (c) parents.

*** = A close associate of a PEP means:

- (a) any person who is known to be the beneficial owner and beneficiary of legal entities, traders or legal arrangements, or who is known to have any other close business relationships with a PEP or a member of a PEP's family; and
- (b) any person who is the beneficial owner and beneficiary of legal entities, traders or legal arrangements known to be effectively established for the benefit of a PEP or a member of a PEP's family.
